





SEPARATION AGREEMENT

THIS AGREEMENT, made and entered into between Michael David McKee hereafter referred to as the "Husband" and Monique Frances Sabaturski, hereafter referred to as the "Wife", both of whom represent that;

WITNESSETH

The parties were married in Columbus, Ohio on August 22, 2015;

There were no children born as issue of this marriage;

Differences have arisen between the parties and they are now living separate and apart from each other;

The parties hereto desire to, and by this Agreement do, completely settle and determine

(a) past, present and future spousal support of each party; (b) the right of any and all property, real and personal whether separate property or marital property; (c) all of the benefits and privileges conferred and all obligations imposed on each by virtue of their marriage relationship or otherwise.

The parties are desirous of entering into this Agreement so that it might be incorporated into a Dissolution of Marriage Decree, pursuant to Section 3105.61- 3105.65, et seq., or a Decree of Divorce, but in any event, to be binding on the parties whether incorporated in either type proceeding.

Both parties have made full disclosure of their financial situation and their property, both real and personal, and each party is duly represented by counsel of their choice or has had the opportunity to obtain and consult with counsel.

1. **CONSIDERATION:** Husband and Wife acknowledge that each has received sufficient consideration of the foregoing promises and mutual promises and undertakings hereinafter specified, the Husband and Wife agree to the following.

In the event there are post-decree issues that require judicial attention, the Parties request that the Franklin County Judge originally assigned to the case take the case back to hear post-decree matters.




