Narrative

NARRATIVE: The following report is a summary of an incident which occurred to my recollection. This report also serves as a summary, of my involvement and understanding, of said incident.

Furthermore, portions of my involvement were recorded by audio and video on my department issued AXON body worn camera. Please review the incident recording(s) for chronological order, exact statements made, and/or for further information outside of this report.

On 12/25/25 at approximately 1021 hours, I, Deputy K. Talley was working uniformed patrol, and driving a fully marked patrol vehicle for the Chelan County Sheriffs Office. I responded to the All Season River Inn, located at 8751 ICICLE RD in Leavenworth, WA for a report of an assault. The victim/reporting party identified herself as Jaime T Phillips [REDACTED]. Jamie told dispatch she received an injury to her nose from a fight last night with her boyfriend Jonathan Riches [REDACTED]. Rivercom was also informed Jonathan had taken Jaime's phone and left last night.

I arrived at the location at the same time as aid. We contacted Jaime at the main entrance door. I could visibly see bruising around Jaime's right eye, consistent with being in the early stages of a black eye. I could also see a small red mark on the upper right corner of the bridge of Jaime's nose. Her nose was visibly not straight and resembled what I have observed through training and experience to be broken. Jaime requested we all speak in the room where her belongings were, which is the Shenandoah room at this location, upstairs.

Jaime advised sometime between 2300-0000 hours last night she had confronted Jonathan about things she observed on his work phone. Jaime stated it was things such as communication with other women and what she described to be porn. Jaime stated when she addressed this with Jonathan he became enraged and struck her with a closed fist multiple times on the side of her head, her nose, and her ribs. Jaime stated she grabbed her phone and began to dial 911 for help, but Jonathan saw her doing this, took her phone from her and said "I will fucking kill you." I asked Jaime if she believed this threat to be true, she stated she believed he would kill her. Jaime stated she believes at some point she lost consciousness after the assault, but remembered Jonathan grabbing 2 bags, his personal cellphone, Jaime's cellphone, and then leaving. I asked Jaime what phone she currently had, and she stated it was Jonathan's work phone that he left behind. Jaime stated she did not know where he went but believed he may have taken the white Jeep Compass they rented. I observed a white Jeep Compass to be parked outside prior to making contact with Jaime. I asked Jaime if she would be willing to have her injuries photographed for documentation, Jaime agreed. Due to most of the medics on scene, and myself to be male, and one of the areas of injury requiring Jaime to lift her shirt, I asked a female medic if she would be willing to take photos of Jaime's injuries with my department issued cellphone in the bathroom of the hotel room, to which she agreed and completed. These photos will be uploaded for evidence. Upon completion of documenting the injuries, Jaime was transported to the Cascade Medical Center for evaluation.

I requested Rivercom to put an ATL out for Jonathan.

I responded to the Cascade Medical Center, and met with Jaime in emergency room number 3. I asked Jaime if she would be willing to complete a medical release form for documentation of injuries received from the assault. Jaime agreed, and a medical release form was completed, signed and provided to the medical facility staff.

Jamie stated Jonathan had been texting the work phone, knowing he left it behind. He told Jaime he was "100 miles away from her" and "in the middle of nowhere". Jaime could not confirm the Jeep Compass still parked at the hotel was their rental, but due to it being the only one there, and all the other guests vehicles accounted for, this was most likely the vehicle. Jaime believed Jonathan to be most likely still in the area, and their flight leaves

tomorrow. Which would require them to travel back to Seattle, and return the vehicle to SeaTac where it was rented.

I was also advised by Jaime that in August of this year, she was on a work trip with Jonathan in Charlotte. This was when she first found out about his infidelity and porn issues. She stated she confronted him, and he attacked her in the hotel they were staying at. Jaime stated it was similar to this, he assaulted her violently and then took their rental car and drove back to Florida, where they live. Jaime stated there is a long history of Jonathan assaulting her in their almost 3 year dating relationship. She stated she knows she should have left many times before this, but hasn't. Jaime stated Jonathan needs to be held accountable for what he did.

After Jaime was discharged from Cascade Medical Center, I was provided a copy of the medical documents for this visit, and I provided Jaime with a courtesy ride back to her hotel. Deputy McComas and I searched the room prior to Jaime going back into it. The onsite manager was contacted, who changed the security code combinations for the front door, and for the room Jaime is staying in.

It should be noted that the white Jeep Compass bearing WA registration CTA6791 that was observed earlier was confirmed to be another guests rental vehicle and was not involved.

I have probable cause to arrest Jonathan L Riches [REDACTED] For violating RCW 9A.36.021 Assault in the 2nd Degree DV, RCW 9A.46.020.2B Harassment threats to kill DV, and RCW 9A.36.150 Interfering with the reporting of domestic violence.

On 12/26/25 I received a text message from Jaime on my department issued cellphone that she cancelled her original flight, and booked a flight with a different airline and boarded without issue.

On 12/27/25 I received a text message from Jaime on my department issued cellphone that she was finally able to track Jonathan's location. He was traveling through North Dakota. It is not know at this time if he is driving back to Florida, or to a different location.


