



I was contacted on 21 December 2012, by Naomi Riches (Plaintiff) in PFA's. Naomi Riches said she had been 302 committed by Jonathan Riches and she was in Fairmount Behavioral System. She said Jonathan claimed she ran into traffic in front of the Justice Center at 201 West Market St. West Chester, PA. She asked if there was any video of the Justice Center? I informer her yes there was on the front of the Justice Center.

Jonathan Riches (Husband) had filed a PFA against Naomi Riches (wife). The Hearing was held on 17 of December 2012 in Courtroom #10 in the Chester County Justice Center at 0900 Hours. Naomi said the alleged incident occurred after the hearing between 1000 and 1200 hours 17 December 2012. She also asked for any reports the Sheriff's Office may have about the incident.

I checked the video for that day between the hours reported. I did not find any incident that occurred in front of the Justice Center, 201 West Market St, West Chester PA. I checked the report system (CODY) and found there were NO incident reports generated that day for any incidents either in the lobby or in front of the Justice Center.

I have also learned that Naomi was present in the Justice Center and the PFA hearing was continued until 24 February 2013 as the Sheriff's Office paper work shows that Jonathan Riches was not served a PFA, nor could I confirm at this time he was in the Justice Center.

I have learned that Jonathan Riches also went to Lancaster County PA and filed another PFA against Naomi Riches. Jonathan Riches has been arrested on violation of Probation and Parole from Chester County Adult Probation and Parole and also Federal Charges are outstanding against him.

Copies of PFA's and information have been supplied to Detectives for additional charges against Jonathan Riches for harassment against Naomi Riches.
