

Affidavit of Aidan Kearney

1. I was in a dating and intimate relationship with Meredith O'Neil [REDACTED] from February 2024 through July of 2025. She began messaging me while I was in jail and began regularly visiting me and sending me videos until my release on February 23, 2024. While I was incarcerated I was extremely lonely and vulnerable, and in hindsight I feel like she preyed on that vulnerability. Within a few weeks of talking to her she had already made plans to buy a house together with me and have a baby, despite the fact that I was still married.
2. Although Meredith has been harassing and tormenting me for the last 8 months, I was hesitant and scared to pursue a restraining order because I realize these hearings are public, and that she would use the proceedings as a way to further torment me. I knew she would mock me for this, as the stigma of a man asking the court for an order of protection against a woman would be used by her to further harass me. I was hoping she would grow tired of harassing me and stop, but she has refused to slow down at all, which is why I feel the need to finally ask this court for an order of protection.
3. While I was in jail it was brought to my attention by a woman named Courtney Healey that this court in South Boston issued a 258E order against Meredith in 2018 when she admittedly hacked into her ex-boyfriend Samuel Teplin's works email account multiple times, and sent his bosses an email pretending to be him, telling them that he no longer wanted to work there. Three months later she admittedly hacked into his account again by guessing his password, and sent another video of him doing cocaine that he didn't know she had recorded. As a result he was fired from his job and broke up with her. He ended the relationship, and Meredith continued to harass him for months afterwards by hacking into his Verizon, Facebook, Gmail, and Apple ID accounts. She also created a Snapchat account that she used to send pornographic images of him to a new woman he was dating. I was petrified that she would do the same to me, and she has done all of that and worse. (See attached court documents)
4. Meredith has deleted her entire Twitter account and all of her YouTube streams, where she had been attacking and defaming me on a daily basis, on the day she applied for a fraudulent 209A order. She did this because she knew that her Twitter and YouTube accounts contain thousands of examples of why she is not in fear of me, and illustrate that she is the aggressor. Luckily I saved screenshots and videos of hundreds of examples of these which are included as evidence in this affidavit.
5. During our relationship we broke up and got back together several times before I ended the relationship for good on July 10. We spoke almost every day and slept at each other's houses. Based on the duration, continuity, and nature of our involvement, this was a substantive dating relationship and qualifies under MGL c. 209A.
6. During our relationship Meredith became controlling and emotionally abusive. She would frequently accuse me of cheating on her with other women who I was just friends with. She monitored my social media and went through my accounts when I was in the shower, taking pictures of my Facebook messages with other women. On October 4, 2024 I attended a fundraiser trivia night in Taunton. After the event was over I went to the bathroom downstairs. When I came back upstairs 2 minutes later Meredith was furious, and accused me of sneaking away to hook up with our mutual friend Lauren Murray. She caused a scene and I didn't want to go home with her, but she was driving my car. I distinctly remember being scared for my life as she aggressively drove nearly 100 mph on I-495 on the drive home.

7. Meredith did cocaine in the apartment where her daughter lives, which she admitted in text messages. She asked me to do it with her and I declined. She also abused alcohol and admitted to me in text messages that she had a drinking problem. She often blamed her abusive behavior on alcohol. **(See Exhibit 1)**
8. After several months of dating I did not want to be with Meredith, but I was afraid to leave her after reading her court records and discovering how she treated her last boyfriend who broke up with her.
9. Every time I tried to break up with Meredith she would manipulate me by pretending to have a panic attack or claiming she couldn't breathe. Other times she would threaten to post things about me that she had learned during our relationship. These tactics worked and kept me in the relationship longer than I wanted to be.
10. On May 27, 2025 Meredith threatened that she was going to post sexual things about me online in an attempt to humiliate me if I didn't show her text messages in my phone. She also mentioned self harm. In a panic I called her repeatedly. She would ignore me and then pick up after several calls, hang up, and get me to keep calling her, like it was a game to her. I ended up going to her apartment that day, leaving my work early, but left her apartment after she once again threatened me. **(See Exhibit 2)**
11. On May 28, 2025 Meredith accused me of cheating on her and demanded to come to my house. I repeatedly told her in text messages not to, and that she was unwelcome there. I told her repeatedly that I was with my 7 year old son, that I was afraid of what she would do, and that she couldn't come over, but she told me to drop him off with his mother because she was coming anyway. She also claimed that she couldn't breathe without seeing me and told me she didn't want to live without me, in an attempt to manipulate me into continuing the relationship. I am in fear that without an order she will show up at my house unwelcomed again. **(See Exhibit 3)**
12. On July 10 I finally ended our relationship for good Meredith came to my house to pick up her belongings, which I left in the mailbox. I was not home, and she sent me a text message showing a giant gash on her wrist which appeared to be self inflicted. She claims that she fell but I believe she was trying to garner sympathy to make me feel bad for her in an attempt to prolong the relationship. **(See Exhibit 4)**
13. When I arrived home Meredith was in my bed crying and her face was covered in blood. This was extremely unsettling and scary. I attempted to break up with her for over 3 hours before she finally accepted it, but wanted to spend the night. I agreed but told her I did not want to be intimate with her, despite her trying to to be intimate with me.
14. Throughout our relationship Meredith would use coercive control in or to regulate and monitor my activities, communications, and movements. She bought me an Apple Watch for Christmas which she hooked up to my phone while I was at the gym on January 30, 2025. She read my private messages, which included messages from a woman who sent me images of her breasts. Meredith video recorded my watch with her phone, showing the woman taking off her shirt and revealing her breasts. She then sent that video to me and several other people without the woman's consent. On multiple occasions Meredith threatened to post the pornographic images of another woman in order to expose me, whenever I tried breaking up with her. It kept me in the relationship much longer than I wanted to, as I felt forced to stay. **(See Exhibit 5)**
15. Meredith said in a live stream that she has since deleted, that she did indeed threaten me with those messages, before stopping herself because she realized how incriminating her words were. **(See Media Exhibit 1)** ***"When I saw her boobs pop up on the watch I was curious who she was. I searched her name and the first thing I saw was them sexting about Karen. So yea I***

brought it up to him and I said what do you think Karen would think about this? There was no like real threat, like, I dunno, maybe it was, I guess, I wanna be careful about what I'm saying here."

16. After finding the pictures of a woman's breasts on my watch, Meredith stole my phone extraction from my bag, which contained all of my phone data up to October 11, 2023. I had previously asked her to download the extraction to help with my legal defense on December 15, 2024, but it was taking too long to download so she couldn't extract the data. On January 2, 2025 she returned the extraction to me and told me it would crash her computer whenever she tried to download the entire thing. After returning it on January 2 she had not downloaded anything from the phone yet. On January 30, 2025 she admittedly stole the extraction because she wanted to learn more about the woman. She said in a February 4, 2025 message to me that she "stumbled upon" it, despite the fact that it was buried in a bag in my room. She read all of my private messages with this woman, and sent me a video she recorded showing a May 2023 conversation with that woman, in which her and I were discussing a sexual fantasy with the third woman. On multiple occasions when I attempted to end the relationship Meredith threatened to post this video showing my discussion of a sexual fantasy with the woman in order to humiliate me and hurt my relationship with the third woman we were discussing. **(See Exhibit 6)**
17. Meredith lied to me about having my Apple Watch for 6 months after stealing it on January 30, 2025. Location data shows that the phone was inside her apartment but she told me in text messages on February 10, 2025, March 31, and April 9 that she couldn't find it. She later admitted to me that it was in her apartment the entire time. **(See Exhibit 7)**
18. An email notification shows that she played a sound on the Apple Watch on February 18, 2025 in order to find it in her apartment, and that she found the device at 2:05 AM on that day. The watch was hooked up to my iCloud as late as July 9, 2025, which means she was actively charging it because it would've died otherwise. During that time I found out that she was reading my messages, monitoring my activity, and had blocked at least 4 women who she found out I had previously messaged which she discovered while going through my stolen phone extraction. I discovered this after one of the women named Chelsea O'Neill messaged me on the Signal app on July 8, 2025 during my show and asked why I blocked her. I unblocked her during my show, but within 10 minutes I noticed she had been blocked again. The location data on the watch showed that it was active inside Meredith's apartment, meaning that she was actively monitoring my phone and blocking women. She did this same exact thing to Sam Teplin's new girlfriend after they broke up in 2018, leading to the granting of a 209A order against her. When I confronted her with this undeniable evidence showing the watch was inside her apartment for the last 6 months, she continued to lie and deny it. When she came to my house on July 10 she finally admitted that she had the watch the entire time and was too embarrassed to tell me the truth. She then returned the watch. **(See Exhibit 8)**
19. Meredith admitted in a deleted live stream on her Twitter account that she stole my extraction and went through it because she wanted to know more about women I had previously had relationships with **(See Media Exhibit 2)**. ***"The phone extract is only stuff through October 2023. Did I go through the whole thing? Absolutely not. Did I search look up the name of the person I found out during our relationship he was cheating on me with? Yes I did, because I wanted to know the background. The Apple Watch thing, I saw one week worth of texts. But I wanted to take it because I wanted to document it. I wanted to take a picture of the whole thing, and then I was embarrassed about what I did so I said I didn't know where it was."***

20. In March 2026 Meredith sent out my entire phone extraction to people she knew were adversarial to me. I discovered this after screenshots of my messages from the extraction began being posted all over Twitter. Meredith was the only person who had access to the extraction besides me which she obtained after stealing it from me on January 30, 2025. She uploaded the entire extraction to a Google Drive with me on March 2, 2025. Meredith was well aware that the phone extraction contained pornographic images of me and other women who had sent me these images privately, and said as much in a Twitter message to a woman named Valerie in November. This was revealed after Meredith herself posted a screen record of her entire conversation with Valerie. Some of the people who she sent the extraction to have publicly mocked the women who sent me naked pictures and sexual messages. **(See Exhibit 9)**
21. Meredith was also well aware that the phone contained privileged communications with my attorneys Kathleen Fay and Marc Randazza, which have been published on social media as well.
22. As a result of Meredith's reckless decision to release my entire extraction, which contained my unredacted phone number, I have received an increasing amount of harassing calls from unknown numbers. She is the only one who had my phone extraction, which she admittedly stole from me during our relationship.
23. My phone extraction contained confidential messages from private sources I used for my journalism in covering the Karen Read case, and those sources have all been doxxed and harassed as a direct result of Meredith's decision to release my entire extraction. One of these sources was Canton Select Board member Patricia Boyden, who was confronted about her private communications with me at a recent Select Board meeting. Another source David Clough is running for Canton Select Board and has been viciously attacked and smeared for emailing me 3 years ago. Another woman who works at Bridgewater State is under investigation for messaging me in August 2023 and called me crying about how she is afraid she will lose her job because people Meredith gave the extraction to began harassing her at her workplace. A friend of mine named Meg is also being viciously attacked. In a recent online broadcast one of the people Meredith sent the extraction to bragged about harming Meg **(Media Exhibit 3): "That extraction with her name in it, now that I know exactly who it is, because there's so many messages from her, people are gonna REALLY know who she is in the coming days."** All of these victims are collateral damage to Meredith's insatiable desire to harm me. Meredith herself has also posted excerpts from my phone extraction. **(See Exhibit 10)**
24. On October 14, 2025, Meredith recorded a conversation between her and I while she was in South Boston and I was in Holden. Both of us were in a 2 party consent state. She later posted the illegal recording on November 28, 2025 in an attempt to harm me, leading the Holden Police to file a criminal complaint against her for felony wiretapping. She wrote "Watch Hill, Rhode Island" at the top of the recording to pretend like she was in a 1 party consent state when she told me on the call that she was in Boston. A clerk's hearing has been scheduled in Leominster District Court. **(Recordings can be heard in Media Exhibits 6 and 7)**
25. On November 22, 2025, Meredith posted a screenshot of a pornographic image of me and a woman named Lindsey Gaetani from a sex video I had previously recorded. This was extremely alarming to me as I had not sent the video to anyone. However, the video was in my Facebook messenger, which Meredith had previously admitted to accessing without my consent because she knew my passwords. **(See Exhibit 11)**
26. When we were in a relationship I was going through a divorce and confided in Meredith, who gave me advice on co-parenting. I valued her opinion because I trusted her and she successfully co-parented her daughter with her ex-boyfriend. One day my daughter was crying and didn't want

to come to my house, so I recorded a video of it and sent it to Meredith to ask her what she thought I should do. The video also contained a private conversation between me and my ex-wife. On December 23, 2025 Meredith shared that video on social media, which was widely shared by many others, harassing my daughter and ex-wife and robbing them of their privacy. **(See Exhibit 12)**

27. Meredith often uses a friend in Australia named Chris Mauler, and another local friend named Pat Tauro (who goes by John Baron on Twitter) to post content she doesn't want to post on her own page because it is illegal or would make her look bad if she posted it. She has fully admitted on Twitter and on YouTube that she will send Chris anything she doesn't want to be seen posting. During a New Years Eve stream she said, ***"There's also a Koala who can get stuff out too, if needed,"*** **(Media Exhibit 4)** when she was asked what else she would be releasing about me. She also announced on Twitter that she would give Chris all her "stuff" on me to post. Chris has posted impounded court documents under protective order in my case, grand jury minutes, private videos of my 8 year old daughter and ex-wife, images from my phone extraction, pictures from the sex video with Lindsey Gaetani, pictures of my Facebook messages that Meredith sent him, and many more materials designed to harm me that he could've only gotten from Meredith. **(See Exhibit 13)**
28. Throughout our relationship and afterwards Meredith compelled me to abstain from or engage in specific behaviors and activity, further illustrating her coercive control. On March 4, 2025 Meredith got drunk and was verbally and mentally abusive to me while I was driving her home from a bar in Canton. During the ride she told me I was a "midget," a "loser," that no one likes me, and that I have wrinkles. She has since admitted to doing this and apologized for it. I told her I didn't want to sleep at her house as a result of that, but she told me I could sleep on the couch. I fell asleep at 1:30 but was awoken by Meredith at 3 AM, demanding that I go to bed with her. I didn't want to do that so I tried to leave. However, Meredith had hidden both my key fob and one of my shoes, making it impossible to leave. I begged her to give them back to me so I could leave, but she refused. I found her phone on the couch had been recording our conversation without my consent, so I began recording for my protection. At 3:51 AM Meredith told me she was going to tell the Boston Police that I hit her so that my bail would be revoked and I would be sent to jail **(See Media Exhibit 8)**. At 3:53 I say on video that I am "so scared" of Meredith because she was going to lie to police and say that I hit her, to which she responds "you did hit me, you literally grabbed me and grabbed my phone" **(See Media Exhibit 9)** At 3:54 she admitted on video that I never hit her **(See Media Exhibit 10)**. At 3:59 she said that I had hit her in a group text message that included me and a mutual friend named Deanna Corby. All I wanted to do was leave, but I couldn't because she stole my key fob and shoe, and I was petrified that she would file a false police report that I hit her if I didn't stay in a relationship with her. As a result I had a panic attack and began crying on the floor. Unbeknownst to me Meredith was recording me while I was crying on the floor. **(See Exhibit 14)**
29. On November 26, 2025 Meredith posted the video of me crying on the floor in her apartment, which I didn't know she filmed until she posted it. She did this prior to any sort of online postings from me about her. Prior to this I only said positive things about her publicly, despite my feelings about her behavior, because I wanted to move on peacefully and protect her image. She has shared this video dozens of times, and it has been viewed millions of times on social media, in an attempt to humiliate and embarrass me. **(See Exhibit 15)**
30. On November 28 I did a live stream discussing why there was a video of me crying on the ground having a panic attack. I outlined the months and months of mental and verbal abuse I had

experienced from Meredith. As a result of me telling the truth about her, Meredith went on a 4 month long campaign on Twitter, defaming me, posting private communications in an attempt to harm me, and attempting to sabotage my legal defense by posting privileged communications between me and my attorneys. She has posted about me thousands of times, including from several burner accounts.

31. According to IP logins from a forensic expert I have hired, Meredith O'Neil began hacking into my Twitter account as early as October of 2025. She knew a common password I used after learning it during our relationship (I sent it to her in a June 28 2025 text message), and was able to access both my Twitter account and the gmail account associated with it, in case I ever changed the password she could get back in through the email. She read private messages sent to me, including a sexual message I sent to a woman. A woman who I had previously messaged with on Twitter had her boyfriend contacted by an anonymous Facebook user, who used a pornographic image of me as a profile picture, and the woman's boyfriend was told that her and I were communicating in a sexual manner, seriously alarming the woman. Meredith has a history of attacking any woman who she believes is in a relationship with me. **(See Exhibit 16)**
32. Meredith frequently uses "burner accounts" on Twitter that she uses to attack me and anyone who supports me. In November 2025 she used an account called "Dragon Besties" to post a picture of the house I was renting at the time. On December 3, 2025 she tagged the employer of my friend Kimberly Whelan and urged the healthcare company she works for to fire her for supporting me. In Twitter messages she told a woman named Valerie that although she denied being behind the account, she had "fed them shit," indicating that she was using the account to anonymously post information about me on her behalf. **(See Exhibit 17)**
33. Meredith ran another burner account called "Hendrick Baron." I know this was her because on March 14, 2026, she used the account to post a screenshot of one of my Twitter DM's to Lindsey Gaetani from January 13. The screenshot of the message was from my perspective and said the message was sent yesterday, meaning she had to be logged into my account to screenshot it, and that the screenshot was taken on January 14. IP logs on my account on January 14 show that Meredith had logged into my account using the password she knew. She mentioned the new woman I was dating (Christine) and called Lindsey a "guttermuppet whore." **(See Exhibit 18)**
34. Meredith used the Henrick Baron account to dox and harass Christine, the woman she found out I was dating. On January 27 she began posting Christine's picture from the crowd at a show I did at the Wilbur Theater. Meredith responded to her fake account (Henrick) with her real account, and said "makes sense" when Christine was accused of being "complicit." Meredith knows that she has 14K Twitter followers, so responding to one of her burner accounts with less than 100 followers with a baseless allegation would dramatically amplify the burner account and get the tweet more views. She uses this technique of responding with her real account frequently in order to gain more followers to her burner accounts like Henrick. In one case she posted on the Hendrick account asking if she should make a graveyard for me, and she responded with her real account saying "absolutely." **(See Exhibit 19)**
35. Meredith continued to harass Christine and her sister by using the Hendrick account to post their faces and tag their employers on Twitter, something she has complained other people do to her. **(See Exhibit 20)**
36. Meredith has used the Hendrick account to harass all 3 of my sisters and one of my brothers by posting their names, faces, and tagging their employers on Twitter. My sister was called down to HR to explain why this was happening after her employer was harassed. Meredith hated my

sister because she didn't approve of our relationship and refused to meet her while we were together. **(See Exhibit 21)**

37. Meredith used the Hendrick account to post pornographic images of me and a former romantic partner named Lauren Murray. These messages were from my stolen phone extraction, which only Meredith possessed at the time. She tagged Lauren in the tweet, and was attacking her in particular because Lauren was friends with both of us, and stopped being friends with Meredith as a result of her online behavior. **(See Exhibit 22)**
38. Meredith also uses an account called Klaus Baron, which I know is her because she uses the account to post things that I gave her. For instance, Klaus posted a love letter that I had written to Meredith while we were together, and she once again used her real account to respond to herself in order to amplify the Klaus account and get more views on the tweet. She also posted messages from my phone extraction, which only her and I had. She used her real account to retweet this account often, in order to amplify the tweet and get it more views. **(See Exhibit 23)**
39. Meredith used the Klaus account to say that she was going to piss on my grave, which I interpreted as a threat to kill me. **(See Exhibit 24)**
40. Meredith used the Klaus account to post the address of a new house I bought. This leaves me in constant fear that she will show up at my house, possibly covered in blood like the day I broke up with her, and do something to hurt me. **(See Exhibit 25)**
41. Meredith used the Klaus account to harass several of my family members and tag their workplaces and non-profits they worked for, including my father, two of my brothers, and the same sister she harassed with the Hendrick Baron account. She used her real account to encourage this behavior by responding to a post harassing my sister by saying ***"I mean, an eye for an eye, if he wants to go after Jen, it's only fair."*** **(See Exhibit 26)**
42. Meredith used the Klaus Baron account to identify the name of the woman whose naked images of her breasts Meredith had stolen from my Apple Watch. I had previously referred to this victim of revenge porn as "Jane." Meredith used the Klaus account to post her real name, in a tweet that also threatened my realtor. She then responded to her Klaus tweet using her real account, and once again posted the name of the revenge porn victim. **(See Exhibit 27)**
43. In December Meredith began to release screenshots of privileged communications between me and my attorneys Mark Bederow and Tim Bradl. Sometimes she would post them, and other times she would have Chris Mauler post them for her. I had sent Meredith these screenshots during our relationship, as she was part of my legal defense team and I was keeping her up to date about our legal strategies, so they could only have come from her. Publication of these messages served no purpose except to harm my legal defense, and cause problems between me and my attorneys, who blamed me for ever trusting her. Her goal was to get Attorney Bederow to withdraw as counsel, because she knew how upsetting it was to him to have his privileged communications posted on her Twitter account, which has over 14,000 followers. The screenshots were used to ridicule my attorneys, reveal our legal strategy, and humiliate all of us. In a December 18 text message Meredith told me she was going to put up an email Attorney Bederow sent me that I had forwarded to her during our relationship, that she would not stop her harassing behavior, and that she would continue to post whatever she wanted, whenever she wanted. **(See Exhibit 28)**
44. Meredith received a lot of criticism for posting privileged communications with my attorneys, but stated in a Twitter post that she was doing this because I had told the truth about her abusive behavior. ***"Life lesson - maybe don't continuously fuck with someone you entrusted so***

much to. So yes, I shared these texts and I'll be happy to share recordings. Stay tuned.
(See Exhibit 29)

45. In December Meredith began posting pictures of my 8 year old son on social media, and then mocked me when I complained about it. (See Exhibit 30)
46. On a December 2025 live stream that she has since deleted, Meredith admitted that she was sharing my privileged communications with my attorneys because people were “fucking” with her by criticizing her online behavior. ***“Meredith knew exactly what she was doing sharing Bederow texts. Well maybe don’t fuck with me. Maybe don’t keep fucking with me.”*** (See Media Exhibit 11)
47. On December 6, 2025 on a since-deleted Twitter live stream, Meredith directly threatened both me and my supporters, and said that it would get much worse if she lost her job as a result of her online postings. ***“If you don’t like what I’m saying now, could you imagine if you did successfully get me fired, how bad I would be then? You never wanna go after one of your enemies and leaving them with nothing to lose. If anybody else tries to do that (contact my work) it’s only going to hurt Aidan. If you think it’s bad now it’s going to be a lot worse.”*** (See Media Exhibit 12)
48. On the December 6 stream Meredith said that she was asking for her 15 year old daughter’s input on what to do to me, and claimed that she had been urged by her daughter to burn me down, and that she was doing this to set a good example for her. ***“That’s what my daughter said. Allie was like, this is just sad for his kids what he’s doing. But now with all the other shit she’s found out what he’s done to Karen she’s like ‘burn him down’.”*** (See Media Exhibit 13)
49. On December 8, 2025, through an intermediary named Jason Broyles, Meredith told me, ***“Tell him it’s gotten out of control, I’m going to police tomorrow and dumping our entire text extract, if he doesn’t call off Holden PD.”*** Jason read and dictated this message to me over the phone, and told me he would confirm she said this to police. This was witness intimidation and extortion, but Jason lied to the police in order to protect her when they called, claiming that he didn’t remember what the message from Meredith said.
50. In December 2025 Meredith posted my financial documents, including an accounting of how much I allegedly paid my lawyers and private investigators. She knowingly lied about the amount that I paid them, and claimed that I paid less money than I actually have paid in order to convince people that I scammed my supporters. She urged people not to donate to my legal defense moving forward. This is an example of coercive control as defined by 209A Section 1, because Meredith “controlling, regulating or monitoring the family or household member’s activities, communications, movements, ***finances, economic resources or access to services***, including through technological means.” She is actively monitoring my economic resources and trying to prevent me from raising more money for my legal defense. (See Exhibit 31)
51. I signed a contract with Compelling Pictures for my movie and documentary rights in 2024. Meredith previously asked me for the contract when we were in a relationship so she could look it over. In December 2025 she posted my contract which showed how much I was being paid for being featured in a documentary and a movie. This is another example of coercive control as defined by 209A Section 1, because Meredith is actively monitoring and posting about my finances and economic resources. (See Exhibit 32)
52. On December 13, 2025 I called Meredith crying and begging her to stop posting privileged communications between me and my attorneys. She told me she wouldn’t, and told me in a voice memo (since deleted) that I “fucked with the wrong person.” I later found out that she illegally recorded the entire phone call (again), as she sent them to a friend of hers in Australia named

Chris Mauler, who posted excerpts from the phone call on his Twitter account. The excerpts show me crying and begging her to stop. Meredith denied that the audio, which only contained my voice, was from a conversation with her, and claimed it was a voicemail I left someone else. **(See Exhibit 33)**

53. Meredith often blamed the behavior of other people on me, and announced that she would punish me for their actions. Due to the fact that she has 14,000 Twitter followers and was constantly using her platform to attack me and my children, many people began to speak out publicly about her. When they did this she would announce that if they continued to talk about her she would continue to release more of my private communications as a way to punish me for their commentary, which she followed through on. In a December 23, 2025 post she announced that she would release 5 privileged text messages between me and my attorneys every time my friend Chelsea O'Neill posted about her. She wrongly accused me of directing Chelsea's actions, when in fact Chelsea was yet another victim of Meredith's online harassment who Meredith wanted to silence by threatening me. **(See Exhibit 34)**
54. Due to the fact that Meredith worked on my legal defense team, she had access to impounded discovery materials, including text messages from witnesses. On January 10 Meredith announced that she would be ignoring the advice of people who urged her to stop talking about me and was doing a show called "Savage Sunday, Unimpoundtown" when she would show impounded discovery messages, bragging that she couldn't get in trouble because the protective order only applied to me. She said she was doing this in the hopes that I would get in trouble for giving them to her. Many of these items have been posted on Twitter by her close associate Chris Mauler, who could only get them from her. Meredith herself bragged on Twitter that she had access to all of the impounded materials in an attempt to get me in trouble with the judge, and began to show impounded communications from Yuri Bukhenik (a detective involved in my case) and Jennifer McCabe (a witness involved in my case). **(See Exhibit 35)**
55. In January Meredith released another video showing impounded materials given to my defense team. This time it was grand jury minutes from Lindsey Gaetani's testimony in my case. **(See Exhibit 36)**
56. In January 2026 Meredith began releasing private video recordings of my ex-wife and 8 year old daughter. These videos were once again posted by Chris Mauler, because she knew it would be a bad look for her to attack a child. In one of the videos it is very disturbing, as my daughter is crying hysterically and doesn't want to come to my house. I had sent Meredith the videos in June 2024 because I was going through a divorce and looking for advice from Meredith on what to do, since she coparents her daughter. I trusted her with this video, and she posted it on the Internet, humiliating my innocent 8 year old daughter for the rest of her life, because she thought it would hurt me. She made sure the videos would be seen by more people by replying to Chris Mauler's tweets whenever he would post a video. Meredith admitted to doing this on one of her deleted YouTube streams, justifying the release of the videos and blaming me because, ***"this is fair game, you shared this with me when we were together."*** **(See Media Exhibit 14)** She admitted in the stream that she was playing this video because my friend James Gillis, who she frequently attacks with homophobic tropes, was talking about her. **(See Exhibit 37)**
57. In December Meredith began threatening to post a recording she claimed to have had of me and Attorney Mark Bederow. I have no recollection of ever recording Mr. Bederow so this was confusing and upsetting to both Mr. Bederow and me. Through an intermediary named Jason Broyles, Meredith said she would refrain from posting the alleged recording if I agreed to give into her demands, which included telling Detective Parker of the Holden Police to drop a criminal

complaint of wiretapping they filed against her, making a public post telling people to leave her alone despite her aggressive online behavior, and demands that I remove any negative posts I had made discussing her abusive behavior. She made specific demands and gave me deadlines on when I had to do as she said, or else she would post the alleged recording. I later found out that no such recording existed, and she was just using it as leverage to get me to drop criminal charges against her for felony wiretapping. Mr. Broyles would frequently send Meredith's extortion messages to me to get me to call the Holden Police and have the charges dropped against her. **(See Exhibit 38)**

58. On January Meredith posted a tweet that said, ***"I wonder if he has learned not to fuck with Meredith O'Neil yet."*** On another post she wrote, "You would think by now they'd know to stop fucking with me," and showed a video of her, me, and Attorney Mark Bederow. **(See Exhibit 39)**
59. On January 21, 2026 Meredith did a YouTube stream where she threatened to leak and post more privileged communications with my Attorney Mark Bederow if I posted about her, or if any friends of mine like James Gillis responded to her public attacks on them. She said: ***"There's no room for pity anymore. This is the point of no return. Go fuck yourself. There's no deals, no deleting. How this goes is totally up to you. It's whether I decide to go into the vault of other shit that I have that I haven't shared, or if things quiet down. Whether more Bederow texts leak, is totally up to your behavior. At this point too, if your friends continue to, if Jimmy continues to, any of them, it's all going to continue. There's no more fucking around with this. Any mention of me from Jimmy, even if you've stopped, then it's not stopping. More Bederow texts can leak, other stuff can leak. There's no room for pity anymore. But this is the point of no return. Go fuck yourself. Even if you've stopped, it's not stopping. More Bederow texts can leak. There's no more fucking around, you can just find out."*** **(See Media Exhibit 15)**
60. On the January 21, 2026 stream Meredith explained that she can monitor my whereabouts using IP locations on a parody Twitter account of mine called "Ghetto Mello" that she admittedly hacked into by guessing my password. On the stream she claimed that an "elite cyber sleuth" team in Australia hacked into my account and gave her the data associated with my accounts in order to distance herself from her crimes. ***"Over the last several days with the help of an elite cyber team overseas evidence has surfaced of my ex boyfriend Aidan Kearney was operating burner accounts on Twitter"*** **(See Media Exhibit 16)**. Chris Mauler took credit for doing this in order to protect her, because he believes he cannot be charged since he lives overseas. He also has gone on streams, using my Ghetto Mello account, as his voice can be heard speaking for the account that Meredith hacked into. As a result of this admitted hacking Meredith knew my exact locations on certain dates because she frequently hacks into my social media accounts. I have received text messages on 8 separate occasions from unidentified masked phone numbers telling me my exact location when I am out socially. This has left me in constant fear that Meredith is monitoring me. **(See Exhibit 40)**
61. On January 24, 2026 Meredith posted that she was going to publish my IP addresses that she obtained by hacking into my social media accounts, and specifically stated that she would by posting the exact dates and times when I was at the home of a woman I am dating in Mansfield. **(See Exhibit 41)**
62. When we were together Meredith purchased a Netflix subscription for me. After breaking up I purchased my own and logged into it on most of my devices. However, the TV in my living room was still logged into the account she purchased. Meredith intentionally kept paying for the account in order to monitor what I was watching. In February 2026, over 7 months after I ended

the relationship, Meredith posted on Twitter that my son had been watching a show called Henry Danger all day, and that I was a negligent parent for allowing him to do so. She shared a screenshot of her Netflix account, showing the exact dates and times of shows my son was watching. (See Exhibit 42)

63. Meredith intentionally changed the name of the Netflix account to "Aidan Fucked Lindsey." She did this so my children would see it when they went to watch shows at my house. This was in reference to Lindsey Gaetani, the woman whose sex tape with me Meredith had previously distributed and posted screenshots from on Twitter. The fact that she changed the name of the account she purchased for me is proof that she was intentionally paying for the account in order to continue to monitor and communicate with me. (See Exhibit 43)
64. In February 2026 Meredith began posting that she was reporting me to the IRS for mortgage fraud, because she wrongly believed that I had lied on my mortgage application about being charged with felonies. She was doing this in an attempt to stop the purchase of a house that I had recently had my offer accepted on and was planning on closing on on March 12, 2026. She did a live stream in which she talked about reporting me for mortgage fraud and suggested there was a 99.9% chance I wouldn't be moving into the house. (See Media Exhibit 17) My realtor Lindsay Higgins was worried about losing her commission as a result of this and messaged Meredith asking her to stop. Chris Mauler also posted Lindsay Higgins' information online to reveal her as my realtor. Meredith told Lindsay that she would not stop because she was upset that she had been fired at State Street as a result of her online behavior. ***"I planned on continuing to talk about Aidan committing mortgage fraud regardless of whether you called me today. He's caused a lot of damage to my life and deserves everything that's coming to him...tell him I said enjoy getting sued into oblivion for what he's done. Mortgage fraud will be the least of his problems coming to him very soon."*** (See Exhibit 44)
65. In an effort to hurt me financially, Meredith urged people to report my YouTube channel in the hopes it would be taken down. YouTube is my largest source of revenue, and losing my channel would be financially devastating. This was yet another way for her to use coercive control to monitor and impair my economic resources. (See Exhibit 45)
66. I am in constant fear of Meredith's behavior, as she is continuing to threaten, intimidate, harass, control, coerce, and compel my compliance, despite ending the relationship 8 months ago. As a result of her behavior I am constantly in fear about what she will do next, if she is monitoring my messages and my movement, and if she will come to my house. For that reason I ask this court for an order of protection so that she stops engaging in this abusive and controlling behavior.
