what are you doing for your community why is everything under your wife's name And what's Lucky Logic LLC?

Is that where you front your money?

Cuz everything's under Charlene's name, not yours.

Hey everybody,

Charlene texted me back.

I was trying to get hold of Chris,
remember? But it was his I thought it
was his number cuz under the Chris Nanos
that's the name his he has a burner
phone. So yes, if you guys remembered I
called and I was like and I left the
message. I was like hey sh I was cuz
remember uh

Chris Nanos you said that to get a hold
of you anybody. So, I I tried to get a
hold of you and I and I asked Charlene
if I could get an interview with your
husband because I don't know the other
whatever the routes are. That was his
phone number, too.

So, I said, "My name's Alex." And I
didn't want to say the number out loud
because I was on my live and uh she
would have seen it in the caller ID. So,
anyway,

she texted me. He she
and at first I was like who the [__] is
texting me? Cuz I didn't. It was like
maybe a hour later.

Let me see.

And I hadn't saved her saved their
number. But now I got their number
saved. So he says call us or call me.

Remember he said call me. You guys heard
me or Kurt heard him. [__]

Hold on. Oh, there it is.

Alex who?

And I didn't I didn't know who it was
until I figured it out. And I was like,
Alex, Alex,

no response, though.

And the only reason I did that is cuz my
kids don't always joke around like that
because some people, how can I explain

So for someone to take these these word these this is this is out of the 26 letters these are the letters I use and people are I don't have time for what's politically correct for 2026 and what's going to be politically correct in two more years I don't give a [__] Okay when you look up [__] in the dictionary it says gay man. So like whether you're gay or not I've been called a [__] all my life. I've called people [__] all doesn't mean that they're a [__] Okay? You could be gay all you want. Okay? I say that all the time. You could be a gay all you want. Just don't act like a [__] Dude, I have gay people in my family. So, like when people say that, dude, like I'm

putting down this whole Dude, this is it. If I say something, am I hurting your feelings? Are you Are you the [__] that is offended? If it is, let me explain something. If you're offended by that, then you need to work on your feelings because it didn't hurt my feelings.

It didn't even touch my feelings. Okay? And if you or anybody out there wants to defend others because I've said something about somebody this or because I said the word [__] or something like that. Well, are you [__] Did it bother you? No. So, in other words, your feelings are hurt because you're feeling for this per like you see what I'm trying to get to. Be concerned of your own feelings because people call me [__] all the time. And you know what? I got to have thick skin. So, you know what? If the word [__] bothers you, it's in the [__] dictionary. Get over it. When I was in court, okay, true story,

And uh if it's cool, legit, it doesn't matter how many subscribers you have, I'll put it up here, guys. Okay. I also like to put all the members up here, but I had to like separate them in like a whole bunch of Anyway, let me keep playing this. What was I doing on the phone?
