On 10/13/2012, in Manatee County, Florida, the defendant did violate F.S.S.- 784.041(2)(a). The victim, who is the defendants co-habitant spouse, alleges that he was involved in a heated altercation with the defendant, who became angry and began breaking items in the residence. The defendant then obtained a kitchen knife and cut the tires on his truck. The victim alleged that she then pushed him down several times causing injury to his right outside forearm. The victim stated that she defendant then punched him in the mouth with her fist causing him to bleed and his front teeth became loose. He stated that the defendant then put her hands around his neck and choked him, however he did not lose consciousness. The victim stated that the defendant then stated that she would kill herself with a knife, however she did not harm herself at that time. The victim declined to complete an affidavit because he stated that he "can't write too well".
