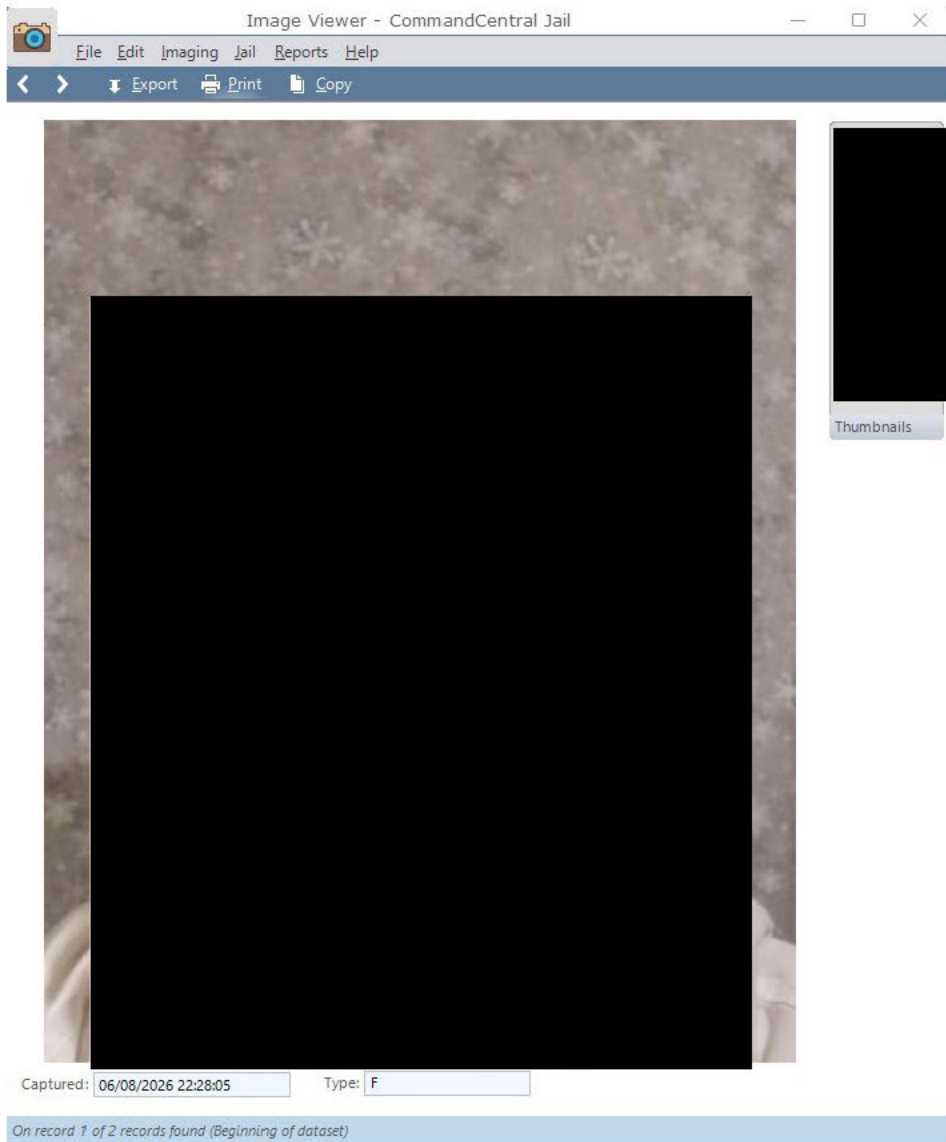

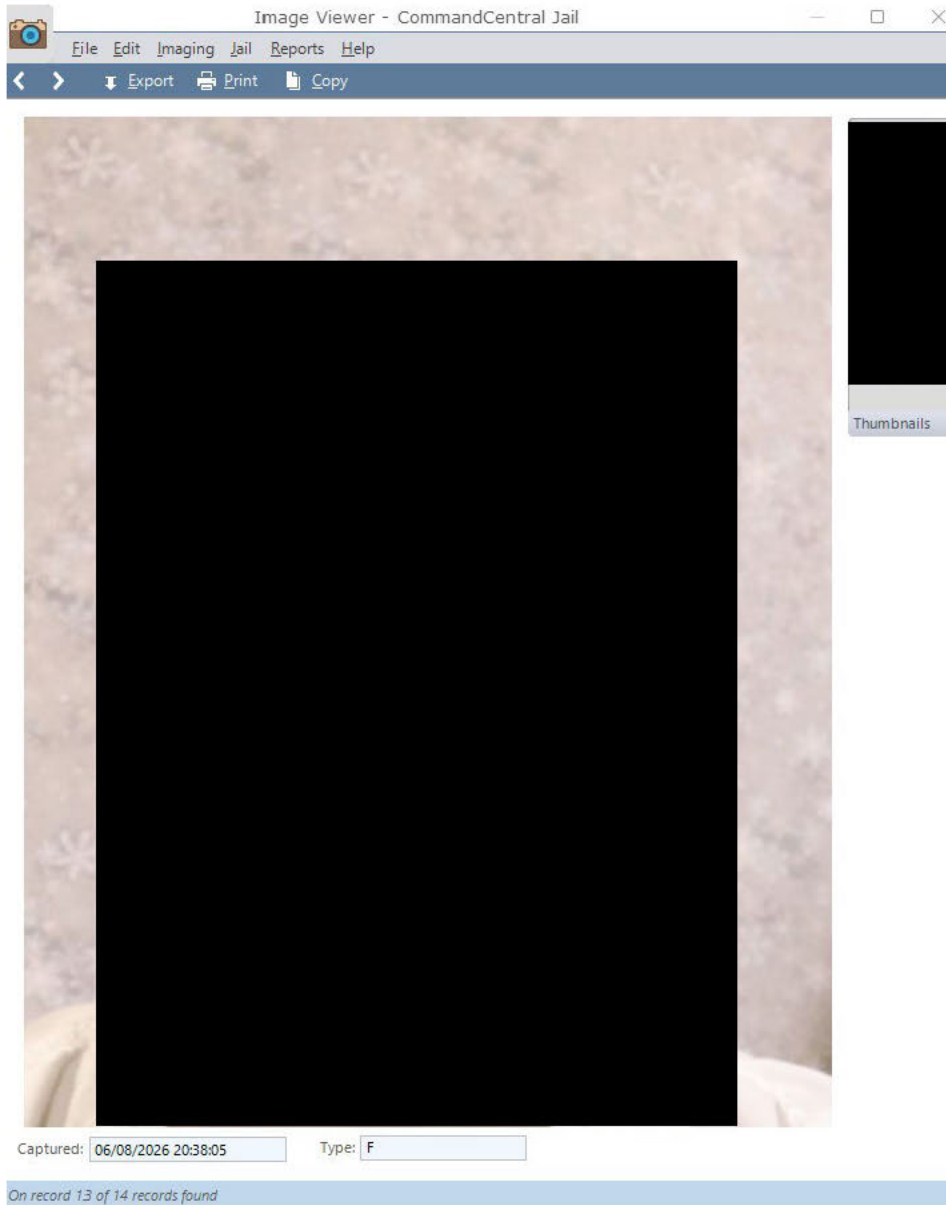

Good morning,

I have attached a link for the spreadsheet that we are still updating and working on. It includes all the case numbers we have located and that have been generated regarding the incidents that have occurred in the immediate Guthrie neighborhood since Guthrie's disappearance.

There have been 87 call numbers generated including a MOP that is being worked by DP/SET (260408203). The MOP itself contains 91 narratives.

During the issuing multiple charges were discussed to include ARS 13-2921 Harassment, ARS 13-2923 Stalking, ARS 13-2916 Use of an electronic communication device to terrify, intimidate, threaten, or harass, and ARS Disorderly Conduct 13-2904. In preparation for the issuing, hours of video from YouTube were watched by Det. Stover, Sgt. Petersen, and me. I am still waiting to hear back from the CA reference the charges. I was told that they were going to do a “deep dive” into the cases as well as applicable laws and case laws before discussing it with their chain of command and putting together a memorandum for us reference their decision. I expect that decision by next week.

The following law enforcement action that has taken place so far between all divisions:

One arrest for trespassing (not a youtuber): Paul Templeton N# [REDACTED] (80 year old tipster doing his own investigation).

One citation for illegal parking: Heidi Ortiz “Juanita” (hangs out with the YouTubers) #260518014.

DP/SET is still investigating several civil infractions that they received emails about over

the weekend.

CPU also is investigating several incidents that occurred over the weekend.

Stephanie is in for a short time this morning before leaving for a medical procedure and she has been working on the excel spreadsheet. If you click on the link and cannot view it in its entirety, she is probably still currently working on it.
